With regard to the request as better formulated above, the applicant

DECLARES

To have fully examined the condition of the track, its equipment and the services offered by Racing in Italy, to have found them absolutely responsive to his/her needs and to have found no defects whatsoever.

To have carefully read the Racing in Italy General terms published on the website, fully accepting the obligations, rates, conditions in force and to scrupulously observe all the rules.

To be in possession of a valid and current document, certifying his/her ability to drive the vehicle, Relevant to the tests that the undersigned intends to carry out.

- 1. That his/her physical and mental conditions are suitable for driving and that he/she does not take substances such as alcohol, narcotics, medicines or other, which could alter its efficiency.
- 2. That his/her technical equipment, worn during the test on the track, is absolutely adequate to the most elementary, important and recognized safety standards. Parag 2. Is not relevant If the equipment is offered by Racing in Italy.

To have received a briefing on the car and the track with all the information necessary to understand the risks involved in entering the track.

I declare that I will treat with care and great respect both the car and the other drivers inside the track.

Therefore declares and confirms to irrevocably release Racing in Italy, the Management, the competent bodies, the employees and the abductees, from ANY RESPONSIBILITY for damages of any kind caused to the undersigned (even if owned by third parties) as a result of any accidents, even if caused directly or indirectly by the state of the track, the equipment or the service personnel. To indemnify in any way in the broadest and absolute manner, for himself and for his successors in any capacity, Racing in Italy, the Management. All bodies, managers, employees and personnel, from ANY and ALL OBLIGATION to pay to anyone and therefore also to third parties and/or transported third parties, sums of money as compensation for damages, indemnities, reimbursements or any other title, depending on accidents of any type, nature and entity, in any case and by whomsoever caused, including Racing in Italy, the Management, its bodies, managers, employees, personnel and/or in any case appointed, on the occasion or during the free trials that the undersigned will have carried out, in fact the compensation for any damage caused directly or indirectly to the structures, to the other drivers, to the mechanical means of anyone and to other third parties, whether spectators, members of the organization, will be TOTALLY and EXCLUSIVELY the responsibility of the declarant.
